***SPECIAL AWARDS***

The Awards Committee of the Wisconsin Chapter of the IAAI is presently in the process of seeking nominations for the various awards that are listed below. These awards will customarily be given at the Annual Spring Meeting of the Chapter. This nomination must be accompanied with incident details, reason for nomination, if it is a civil or criminal proceeding, and whether the case is resolved and what the resolution was.

The awards available are listed below:

**1. INVESTIGATOR OF THE YEAR**

One of these awards may be given each year. This award will be given to a person who has demonstrated outstanding accomplishments in fire investigations in both the civil and criminal fields of arson control and has acted above and beyond the normal duties expected or mandated by the nominees' profession. Written nominations for a candidate must be received from three separate people before a person can be considered for this award.

**2. DISTINGUISHED SERVICE AWARD**

One of these awards may be given each year. This award will be given to a person who has provided outstanding service, effort and direction to the purposes and objective of the Wisconsin Chapter of the IAAI. This person must be a member of the Wisconsin Chapter.

**3. KEY AWARD**

One of these awards may be given each year. The nominees for this award should be a person who has been the key initiating factor in starting a successful fire investigation resulting in a criminal conviction or civil judgment. This award can be given to any person who qualifies. Examples are: Citizens, Pumper Drivers, Patrol Officers, etc.

**4. TEAM AWARD**

One of these awards may be given each year, and can be awarded to any recognized team of investigators who as a result of a team effort gain a fire related criminal conviction or civil judgment.

**5. AWARD OF RECOGNITION**

Three of these awards may be given each year. This award may be given to any individual or organization, member and/or non-member of the Wisconsin Chapter, for services rendered to the Chapter and its purposes.
